1) Statutory Requirement for School Websites

On 1st September 2016, new regulations come into force regarding school information on school websites. These are amendments to the School Information (England) Regulations 2008 and apply to maintained schools only. 3. Link to Ofsted Report

5. Link to school performance tables on www.education.gov.uk
6. School curriculum information for each year group by subject, including phonics/reading schemes and key stage 4 courses/qualifications as appropriate
7. Behaviour policy
8. Pupil Premium allocation and Year 7 literacy and numeracy catch-up premium grant was spent and its impact on attainment.
9. SEN policy
10. Charging and remissions policy
11. School's ethos and values

The governing body is responsible for:

- Ensuring that the information above is published on the school website – or arranging for the information to be displayed on a website, and the address/details made known to parents
- Providing a paper copy of the information published on the website, without charge, to parents on request
- Making sure that the information is updated as soon as is reasonably practicable following a change to that information and, in any event, at least annually

2) Website Privacy Policy

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information.

(1) What information do we collect?

We may collect, store and use the following kinds of personal data:

1. Information about your visits to and use of this website;
2. Information about any transactions carried out between you and us on or in relation to this website;

(2) Information about website visits

We will take reasonable precautions to prevent the loss, misuse or alteration of your personal information. Of course, data transmission over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.
